FD Resignation: Motion made by Smith, seconded by English to accept the resignation of Justin Gay. Motion Carried.


FD Priority 3 Calls: Assistant Chief Darrell Schultz explained what a Priority 3 call was and explained that the FD along with the PD are working together on this.
